#### MODULE 8: NON-STANDARD

#### Introduction and explanation

Following discussions at the ICTV Executive Committee meeting in Edinburgh (EC45) on 17 July 2013, it was agreed to propose changes to the Statutes to allow the appointment of a third secretary, with particular responsibility for virus data.

Currently, virus data is the responsibility of one of the subcommittees, but this historic arrangement no longer best serves current needs. In particular, it does not provide sufficient continuity for managing the web sites that now support all the operations of ICTV. These web sites (1) provide the latest virus taxonomy to the public in accessible form; (2) are essential for submission and management of taxonomic proposals under discussion (providing opportunity for public comment); (3) act as an archive for all past taxonomic decisions; and (4) act as the public face of ICTV with information about its organization, listing and acknowledging the work of the many specialist Study Groups. Most importantly for the future, it is now intended that the ICTV Report will be prepared and presented in an online format managed by ICTV itself. Because of the importance of all these activities, it would be best for them to be under the day-to-day management of an ICTV Secretary, a position that has a 6 year term that is renewable. The two existing secretaries would remain responsible for the processing and tracking of taxonomic proposals, for the administration of ICTV business and are expected to have major roles in editing the content of the ICTV Report.

We propose to retain six subcommittees to help manage the increasing volume of taxonomic proposals. This change would therefore increase the overall size of the Executive Committee from 18 to 19 members.

The composition of the ICTV Executive Committee shall be:-

B. Two Secretaries shall be nominated by the Executive Committee and elected at a plenary meeting of the full ICTV membership. The Secretaries shall be elected for a term of six years and may be re-elected.

B. Three Secretaries shall be nominated by the Executive Committee and elected at a plenary meeting of the full ICTV membership. The Secretaries shall be elected for a term of six years and may be re-elected.

- B. To prepare with the President the agendas for meetings of the EC and the plenary meetings of the ICTV.
- C. To prepare the Minutes of meetings of the Executive Committee and plenary meetings of the ICTV and ensure their timely publication on an ICTV web site.
- D. To keep an up-to-date record of ICTV membership.
- E. To manage the submission and processing of taxonomic proposals
- F. To maintain the ICTV web site and databases that provide up-to-date taxonomic information, information on ICTV activities and membership, the ICTV Report and other outreach activities.
